

## **TERMS & CONDITIONS**

**RTB Day Berlin'26 — 16 April 2026**  
**Fotografiska Berlin**

### **I. GENERAL PROVISIONS**

1. These terms and conditions (the "**Terms & Conditions**") govern participation in the one-day "**RTB Day Berlin**" event (the "**Event**") to be held on **16 April 2026** at **Fotografiska Oranienburger Str. 54, 10117 Berlin - Mitte**.
2. The **Organizer** of the Event is **RTB HOUSE GmbH**, German Limited Liability Company seated in Berlin at Kurfürstendamm 226, 10719 Berlin, Germany, registered with the Commercial Register of the Local Court (Amtsgerichts) of Charlottenburg under no HRB: 192827 B, Tax ID: 27/499/50041 ("**RTB House**" or the "**Organizer**").
3. **Participation in the Event is free of charge**; registration and acceptance of an invitation constitute acceptance of these Terms & Conditions.
4. Information on personal-data processing is provided in a separate **Privacy Policy**.

### **II. DEFINITIONS**

**Participant** – an individual invited by the Organizer who has duly registered.

**Venue** – the designated area of **Fotografiska Berlin** or another location indicated by the Organizer.

**Security Staff** – licensed security personnel engaged by the Organizer.

### **III. ADMISSION CONDITIONS**

1. Admission is granted to holders of a valid invitation and a government-issued photo ID.
2. Security Staff will refuse entry to persons:
  - A. under the influence of alcohol or intoxicants
  - B. carrying weapons, dangerous materials or alcohol;
  - C. behaving aggressively.

### **IV. SAFETY AND CONDUCT**

1. Participants must follow Security Staff instructions and health-and-safety signage.

- 2.** It is prohibited to damage equipment, remove property or bring animals (except assistance dogs) into the Venue.
- 3.** The Organizer may expel from the Venue any person violating these Terms & Conditions.

## **V. LIABILITY**

- 1.** The Participant is liable for any damage caused during the Event.
- 2.** To the fullest extent permitted by applicable law, RTB House disclaims liability for any indirect or consequential damages, provided that such exclusion shall not apply to damages resulting from intent or gross negligence.
- 3.** RTB House's total aggregate liability is limited to **EUR 1,000**.
- 4.** The Participant shall indemnify RTB House against third-party claims arising from breach of these Terms & Conditions.
- 5.** RTB House is not liable for unattended belongings; personal insurance is recommended.
- 6.** Nothing herein limits liability that cannot be limited under mandatory law.

## **VI. IMAGE RECORDING**

- 1.** The Organizer may record the Event for documentation and promotional purposes.
- 2.** Entry constitutes consent to the free use of one's image.
- 3.** Details may be set out in a separate statement.

## **VII. COMPLAINTS**

- 1.** Complaints may be submitted in writing within 14 days of the Event.
- 2.** A complaint should include personal details and a description of the issue.

## **VIII. FINAL PROVISIONS**

- 2.** The Organizer may amend the Terms; amendments take effect upon publication.
- 3.** Matters not covered herein are governed by German law.
